# 1 Purpose and Scope

3. **Continuously improving:** Optimizing processes, products, and services to enhance quality as well as environmental and energy performance
4. **Protecting the environment:** Permanently reducing resource consumption, emissions, wastewater, waste, and noise, promoting the circular economy and preventing environmental pollution
5. **Continuously improving energy performance:** Targeted use and further development of renewable energy and energy-efficient technologies
6. **Adopting a lifecycle approach:** Considering product durability, resource efficiency, energy efficiency, and recyclability throughout the entire lifecycle, including development, use, maintenance, and disposal

## QUALITY AND CUSTOMER SATISFACTION

- Customer expectations are reliably met and, where possible, exceeded. Error prevention, adherence to deadlines, and economic efficiency characterize the way of working; continuous improvement and adaptation to changing requirements are firmly embedded in the corporate culture.
- Training and continuing education ensure a high level of qualification; qualification profiles and training measures are planned, documented, and regularly reviewed; knowledge transfer is actively promoted.

## ENERGY

- Modern and energy-efficient infrastructure is specifically promoted through investments and considered in new construction projects, refurbishments, and the acquisition of new equipment and machinery.
- Internal energy demand is covered by renewable energy wherever technically and economically feasible.
- The efficiency of energy-intensive equipment is regularly reviewed and continuously improved.

## ENVIRONMENT

- Resources are managed responsibly and closely monitored to reduce consumption.
- Waste, wastewater, emissions, and noise are continuously reduced through efficient processes and modern facilities; investments in efficient machinery and equipment ensure ongoing improvement.
- Charging infrastructure for electric vehicles is provided at selected Anton Paar locations and expanded as required.

## SUPPLY CHAIN

- When selecting suppliers, ecological, social, and quality-related criteria are considered. Long-term partnerships based on shared values are promoted.
